Clause 1 – Engagement and Services

The Actor agrees to perform the role described herein for the Producer in connection with the Production. The Actor shall render such services faithfully and to the best of their ability in accordance with industry standards.

Clause 2 – Term and Availability

The engagement shall commence on the agreed Start Date and shall continue for the Duration or until the End Date specified. The Actor shall be available for rehearsals, promotional activities, and other reasonable requests related to the Production during this period, subject to prior agreement.

Clause 3 – Fees and Expenses

The Producer shall pay the Actor the Total Fee as full compensation for all services rendered under this contract. Unless otherwise agreed in writing, the Producer shall reimburse pre-approved reasonable expenses incurred by the Actor in the course of performing under this Agreement.

Clause 4 – Rights Granted

The Actor hereby grants the Producer the irrevocable, worldwide, perpetual right to use the Actor's performance and likeness in all media, now known or hereafter devised, for the purposes of the Production and its exploitation.

Clause 5 – Confidentiality

The Actor agrees to keep confidential all proprietary information, scripts, plot details, and other information related to the Production that is disclosed to them prior to or during the engagement. This obligation shall survive the termination of this Agreement.

Clause 6 – Intellectual Property

All materials created by the Actor in connection with the Production shall be considered works made for hire and shall be the sole property of the Producer. The Actor waives any moral rights or claims related to such materials.

Clause 7 – Termination

Either party may terminate this Agreement for material breach by the other party, provided that written notice is given and the breach remains uncured after a reasonable period. Termination shall not affect accrued rights or obligations.

Clause 8 – Conduct

The Actor agrees to conduct themselves professionally and comply with all applicable laws and regulations, including health and safety requirements. The Producer may terminate this Agreement immediately for gross misconduct.

Clause 9 – Insurance and Liability

The Producer shall maintain appropriate production insurance. The Actor is responsible for their own personal insurance. Neither party shall be liable to the other for indirect or consequential damages.

Clause 10 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The courts of England and Wales shall have exclusive jurisdiction to settle any disputes arising out of or in connection with this Agreement.

Clause 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations and agreements relating to the subject matter hereof. Any amendments must be in writing and signed by both parties.

Clause 12 – Notices

All notices under this Agreement shall be in writing and delivered by hand, pre-paid post, or email to the addresses specified above or as otherwise notified in writing.

Clause 13 – Force Majeure

Neither party shall be liable for any failure or delay in performing their obligations due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, or government restrictions.

Clause 14 – Data Protection

Both parties shall comply with applicable data protection laws. Personal data shall be processed only for purposes related to this Agreement and handled securely.

Clause 15 – Independent Contractor

The Actor is engaged as an independent contractor and nothing in this Agreement shall create an employment relationship, partnership, or agency between the parties.

Clause 16 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remainder shall remain in full force and effect.

Clause 17 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original.

Clause 18 – Signature

The parties have executed this Agreement as a deed on the date it was signed by the last party to sign.
