hold harmless the accompanying adult(s) and any agents from liability arising from the child's travel, except in cases of gross negligence or willful misconduct.

**5. Documentation**

The child shall carry all necessary travel documents, including passport and visas if applicable. I understand that it is my responsibility to ensure these are valid and up-to-date.

**6. Duration of Consent**

This consent shall remain valid for the duration of the travel specified herein unless revoked in writing by me prior to travel.

**7. Governing Law**

This consent form shall be governed by and construed in accordance with the laws of England and Wales.

**8. Signatures and Witness**

This form must be signed by the consenting parent/legal guardian and witnessed by an independent adult (not accompanying the child) who attests to the identity and signature of the consenting party.
