Terms and Conditions:

1. Scope of Services

The Dog Walker agrees to provide dog walking services for the Client's dog as described above, in a safe, responsible, and professional manner.

2. Client Obligations

The Client confirms that the dog is in good health, up to date with vaccinations, licensed, and free from parasites and contagious diseases. The Client agrees to provide all necessary supplies and accurate information about the dog's behaviour, health, and special needs.

3. Safety and Control

The Dog Walker shall use appropriate equipment such as leashes and harnesses. The Dog Walker will take reasonable

precautions to prevent injury or escape but is not liable for events beyond reasonable control.

4. Emergencies

In the event of an emergency involving the dog's health or safety, the Dog Walker shall attempt to contact the Client immediately. If the Client is unreachable, the Dog Walker is authorized to seek veterinary care and the Client agrees to reimburse all related costs.

5. Liability

The Dog Walker is not liable for injury, illness, or death of the dog caused by circumstances outside of the Dog Walker's control, including but not limited to the dog's own behaviour, third parties, or environmental hazards. The Client indemnifies the Dog Walker against any claims arising from the dog's behaviour.

6. Cancellation and Rescheduling

Either party may cancel or reschedule walks with at least 24 hours' notice. The Client is responsible for payment of cancelled walks without adequate notice.

7. Term and Termination

This Agreement shall continue until terminated by either party with written notice. Outstanding fees shall remain payable upon termination.

8. Confidentiality

Both parties agree to keep all personal information and details of this Agreement confidential, except as required by law or with prior consent.

9. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. Any disputes arising shall be subject to the exclusive jurisdiction of the courts of England and Wales.

10. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes all prior discussions and agreements. Any amendments must be in writing and signed by both parties.
