Clause 1 – Appointment

Clause 6 – Confidentiality

Clause 7 – Termination

Either party may terminate this nomination by providing written notice to the other party. Termination shall not affect

any rights or obligations accrued prior to termination.

Clause 8 – Governing Law and Jurisdiction

This Nomination Form shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales to resolve any disputes arising out of or in connection with this nomination.

Clause 9 – Entire Agreement
