Clause 1 – Contract Formation

This Agreement constitutes a legally binding contract between the Seller and the Buyer for the purchase and sale of the item described herein under the terms specified.

Clause 2 – Description and Condition

The Purchased Item is sold as described above. The Buyer acknowledges having inspected the item or waived such inspection and accepts the item in its present condition, subject to disclosures made by the Seller.

Clause 3 – Title and Risk

Title to and risk of loss or damage to the Purchased Item shall pass from the Seller to the Buyer upon full payment and delivery, whichever occurs later.

Clause 4 – Payment

Payment shall be made by the Buyer as specified under the Payment Terms. Failure to pay as agreed constitutes a breach of this Agreement.

Clause 5 – Delivery

The Seller shall deliver the Purchased Item to the Buyer at the agreed location. Delivery costs and responsibilities shall be as agreed by the parties.

Clause 6 – Warranties and Representations

The Seller represents that it has good and marketable title to the Purchased Item, that it is free from all liens and encumbrances, and that the Seller has the full right to sell the item. Except as expressly provided, the item is sold without warranties, express or implied.

Clause 7 – Inspection and Acceptance

The Buyer has the right to inspect the Purchased Item prior to completion. Acceptance of the item shall be presumed upon delivery and payment unless otherwise agreed.

Clause 8 – Default

If either party fails to perform their obligations under this Agreement, the non-defaulting party may pursue all remedies available at law or equity, including termination and damages.

Clause 9 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England.

Clause 10 – Entire Agreement

This Agreement, together with any written schedules or attachments, constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, or agreements.

Clause 11 – Amendments

No amendment or variation to this Agreement shall be effective unless made in writing and signed by both parties.

Clause 12 – Notices

Any notices required or permitted shall be in writing and delivered personally or sent by recorded delivery or email to the addresses specified.

Clause 13 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

Clause 14 – Counterparts

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

Clause 15 – Confidentiality

The parties agree to keep the terms and existence of this Agreement confidential, except as required by law or with prior written consent.

Clause 16 – Data Protection

The parties shall comply with applicable data protection laws in processing any personal data arising from this

Agreement.

Clause 17 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond reasonable control, including but not limited to acts of God, war, or government action.

Clause 18 – Assignment

Neither party may assign or transfer their rights or obligations under this Agreement without the prior written consent of the other party.

Clause 19 – Interpretation

Headings are for convenience only and shall not affect interpretation. Words importing the singular include the plural and vice versa.

Clause 20 – Signatures

The parties have executed this Agreement as a deed on the date first above written.
