The Supplier warrants that the Goods supplied under this Contract shall be of satisfactory quality, fit for purpose, conforming to the specifications, and free from defects in design, material, and workmanship. The Supplier has full right and authority to supply the Goods and Services and that the Goods are free from any third-party claims.

Inspection and Acceptance:

The Buyer shall inspect the Goods upon delivery and notify the Supplier within a reasonable time of any non-conformance or defects. Failure to notify within such time shall constitute acceptance of the Goods. Accepted

Goods shall not be returned except as agreed in writing.

Confidentiality:

Each party agrees to keep confidential and not disclose to any third party any confidential information received from the other party in connection with this Contract, except as required by law or with prior written consent.

Limitation of Liability:

Neither party shall be liable to the other for any indirect, incidental, consequential, or punitive damages arising out of or in connection with this Contract. The total liability of either party shall not exceed the total Contract Price.

Force Majeure:

Neither party shall be liable for any delay or failure in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, civil commotion, governmental actions, or natural disasters.

Termination:

Either party may terminate this Contract by giving written notice if the other party commits a material breach and fails to remedy it within a reasonable period. Termination shall not affect rights and obligations accrued prior to termination.

Governing Law and Jurisdiction:

This Contract shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales to settle any disputes arising out of or in connection with this Contract.

Entire Agreement:

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and negotiations whether oral or written relating to its subject matter. Any amendments must be made in writing and signed by both parties.

Severability:

If any provision of this Contract is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

Notices:

Any notice or communication required or permitted under this Contract shall be in writing and shall be deemed duly given if delivered by hand, sent by registered post, or email to the addresses of the parties as set out in this Contract or as otherwise notified in writing.
