Clause 1 – Agreement to Hire

The Owner agrees to hire and the Hirer agrees to take on hire the vehicle described above on the terms set out in this Agreement.

Clause 2 – Condition of Vehicle

The Hirer acknowledges having inspected the vehicle and accepts it in its current condition. The Owner warrants that the vehicle is roadworthy and complies with all applicable legal requirements in the United Kingdom.

Clause 3 – Hire Period

The hire period shall commence and end as specified above. Any extension of the hire period must be agreed in writing by both parties prior to the expiry of the original hire period.

Clause 4 – Use of Vehicle

The Hirer shall use the vehicle only for the permitted purposes and within the permitted area of use. The vehicle shall not be used for any illegal purpose, racing, or towing.

Clause 5 – Payment

The Hirer shall pay the hire charges, deposit, and any other sums due in accordance with the agreed payment method and schedule. Failure to pay may result in termination of this Agreement by the Owner.

Clause 6 – Deposit

The deposit shall be held by the Owner as security for the performance of the Hirer's obligations and for any damage to the vehicle. The deposit will be refunded to the Hirer within a reasonable time after the end of the hire period, subject to deductions.

Clause 7 – Damage and Loss

The Hirer is responsible for any damage to or loss of the vehicle during the hire period, except for fair wear and tear. The Hirer shall notify the Owner immediately of any damage, accident, or theft.

Clause 8 – Insurance

The Owner shall maintain valid insurance covering the vehicle. The Hirer must comply with the terms of such insurance and shall be liable for any insurance excess payable as a result of a claim during the hire period.

Clause 9 – Maintenance and Repairs

The Owner shall ensure the vehicle is maintained in good working order. The Hirer shall not make any repairs or modifications without prior written consent from the Owner.

Clause 10 – Breakdown

In the event of a breakdown, the Hirer shall notify the Owner immediately and shall take reasonable steps to minimize loss or damage to the vehicle.

Clause 11 – Termination

Either party may terminate this Agreement immediately if the other breaches any material term. Upon termination, the Hirer shall return the vehicle to the Owner immediately.

Clause 12 – Return of Vehicle

The Hirer shall return the vehicle in the same condition as received, except for reasonable wear and tear, and with a full tank of fuel unless otherwise agreed.

Clause 13 – Liability

The Owner shall not be liable for any indirect, consequential, or special losses arising from the hire of the vehicle. The Hirer shall indemnify the Owner against all claims arising from the Hirer's use of the vehicle.

Clause 14 – Personal Data

The parties agree to process each other's personal data in accordance with applicable UK data protection laws and solely for purposes of performing this Agreement.

Clause 15 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales.

Clause 16 – Entire Agreement

This Agreement constitutes the entire agreement between the parties relating to the hire of the vehicle and supersedes all prior agreements and understandings.

Clause 17 – Amendments

No amendment, variation, or addition to this Agreement shall be effective unless made in writing and signed by both parties.

Clause 18 – Notices

Any notice under this Agreement shall be in writing and deemed duly given if delivered by hand, by recorded delivery post, or by email with confirmation of receipt.

Clause 19 – Severability

If any provision of this Agreement is found to be unenforceable, that provision shall be severed and the remainder of the Agreement shall continue in full force and effect.

Clause 20 – Counterparts and Electronic Signatures

This Agreement may be executed in any number of counterparts, each of which when executed shall be an original, and all counterparts together shall constitute the one Agreement. Electronic signatures shall be deemed valid and binding.
