1. Acknowledgment of Risk

I, the undersigned Participant, acknowledge that I am voluntarily participating in the activity described above, fully aware that the activity involves inherent risks, dangers, and hazards that can result in serious personal injury, death, or property damage. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity.

2. Release and Waiver

In consideration of being permitted to participate, I hereby release, waive, discharge and covenant not to sue the Organiser, its officers, employees, agents, volunteers, and affiliates (collectively, the "Released Parties") from any and all liability, claims, demands, actions or causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or to any property belonging to me, whether caused by negligence of the Released Parties or otherwise, while participating in the activity or while in, on or upon the premises where the activity is being conducted.

3. Indemnification

I agree to indemnify and hold harmless the Released Parties from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in the activity, whether caused by negligence of the Released Parties or otherwise.

4. Medical Condition and Emergency Treatment

I declare that I am physically fit and capable of participating in the activity. I consent to receive medical treatment which may be deemed advisable in the event of injury, accident, or illness during the activity. I understand that I am solely responsible for all costs related to such medical treatment.

5. Compliance with Rules

I agree to comply with all rules, regulations, and instructions provided by the Organiser related to the activity. I understand that failure to comply may result in my removal from the activity without refund.

6. Photography and Use of Likeness

I grant permission to the Organiser to take photographs, video recordings or other images during the activity and to use such media for promotional, educational, or other purposes without compensation or approval rights.

7. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. Any disputes arising out of or related to this Agreement shall be subject to the exclusive jurisdiction of the courts of England and

Wales.

8. Severability

If any provision of this Agreement is found to be unenforceable or invalid under any applicable law, such unenforceability or invalidity shall not render this Agreement unenforceable or invalid as a whole, and such provisions shall be deleted without affecting the remaining provisions herein.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior or contemporaneous understandings, representations, warranties and agreements, whether written or oral, regarding such subject matter.

10. Voluntary Agreement

I acknowledge that I have read this Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
