Clause 1 – Parties and Purpose

This Agreement is entered into by and between the parties named above for the purpose of solemnising their marriage and the provision of wedding-related services on the terms set forth herein. Both parties affirm that they are legally free to marry under the laws of the United Kingdom.

Clause 2 – Wedding Services

The service provider (if applicable) shall provide the agreed wedding services as detailed in attached schedules or appendices. The parties shall cooperate fully to facilitate a smooth and timely wedding event.

Clause 3 – Payment and Deposits

The total contract amount is payable as per the payment schedule outlined above. Deposits are non-refundable except as expressly provided herein. Final payment must be made prior to the date of the wedding unless otherwise agreed in writing.

Clause 4 – Cancellation and Postponement

Either party may cancel this Agreement by written notice to the other. Cancellation fees and refunds, if any, shall be governed by the terms specified in this Agreement or applicable schedules. Postponements require mutual written

agreement and may incur additional fees.

Clause 5 – Legal Compliance

The parties warrant that all information provided is true and accurate and that the wedding ceremony and associated activities shall comply with all applicable laws, regulations and licensing requirements in the United Kingdom.

Clause 6 – Liability and Indemnity

Each party agrees to indemnify and hold harmless the other party and any service providers against any losses, damages, claims or expenses arising from breach of this Agreement, negligence, willful misconduct, or failure to comply with applicable law.

Clause 7 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, government restrictions, pandemics, or other unforeseen events.

Clause 8 – Confidentiality

All personal information and details of this Agreement shall be kept confidential except as required by law or consented to by the parties in writing.

Clause 9 – Entire Agreement

This Agreement, together with any attached schedules or addenda, constitutes the entire agreement between the parties and supersedes all prior discussions or agreements relating to its subject matter.

Clause 10 – Amendments

Any amendments or modifications to this Agreement shall be valid only if made in writing and signed by both parties.

Clause 11 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales for any disputes arising out of or in connection with this Agreement.

Clause 12 – Dispute Resolution

In the event of any dispute, the parties agree to attempt resolution through mediation or other alternative dispute resolution methods prior to commencing legal proceedings.

Clause 13 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 14 – Notices

All notices under this Agreement shall be in writing and delivered by hand, recorded delivery post, or email to the addresses provided by the parties.

Clause 15 – Signatures

This Agreement may be executed in counterparts, each of which is deemed an original and all of which constitute one and the same instrument. Electronic signatures shall be deemed valid and binding.
